PORTER SQUARE TO GET AFFORDABLE HOUSING

Capstone Communities LLC and Hope Real Estate Enterprises LLC plan to develop a 40-unit affordable apartment complex at 1785-1791 Massachusetts Ave. in Cambridge's Porter Square neighborhood. Rockland Trust provided a \$17.7 million financing package for the project, including a \$8.7 million construction loan and \$9 million in low-income housing tax credit equity, and the Massachusetts Housing Investment Corp. also provided a \$4.3 million loan. The building will be named Frost Terrace and have a combined 39 one-, two- and three-bedroom apartments and one studio apartment.
